- Payments can be made to any Bank Tejarat branch nationwide with a 24 hour processing delay within Tehran city limits and a maximum of 48 hour processing delay outside Tehran.
- The original receipt for the payment must be submitted with the application.
- If the Visa Application Charge has been paid in an office of Immigration in Australia, please provide the original receipt for payment with the application.
- The Australian Embassy **does not** accept payment for skilled independent visa applications. These must be paid by credit card or bank draft and sent with the application directly to the Adelaide Skilled Processing Centre.
